- RESPONSE TO THE RECOMMENDATIONS OF THE PUPIL ACCOMMODATION REVIEW COMMITTEE

TO Planning and Priorities Committee 10 June 2015

RECOMMENDATION IT IS RECOMMENDED:

- 1. That the attendance area for D.A. Morrison Middle School be expanded to include the entirety of the Gledhill Junior Public School junior attendance boundary effective September 2016; and
- 2. That Gledhill Junior Public School be converted from a Junior Kindergarten to Grade 6 school to a Junior Kindergarten to Grade 5 school effective September 2018.

STRATEGIC DIRECTION

Make every school an effective school.

RATIONALE

In March 2012, the Board approved the establishment of a Pupil Accommodation Review Committee (PARC) for D.A. Morrison Middle School, Gledhill Junior Public School, Parkside Elementary School and Secord Elementary School. The named schools are located in Ward 16 (Trustee Cary-Meagher). Appendix A shows the location of the schools.

The PARC was formed to identify the feasibility of converting Secord ES from a Junior Kindergarten to Grade 5 school to a Junior Kindergarten to Grade 8 school, to identify the appropriate utilization of existing school space in the area, and to plan for future enrolment growth.

The PARC began its work in April 2012. The PARC included members of the school community such as parents and staff. After three working meetings and four public meetings, the PARC submitted its final report with recommendations in October 2012.

The PARC made the following recommendations:

- That Secord ES convert from a Junior Kindergarten to Grade 5 school to a Junior Kindergarten to Grade 8 school;
- That Parkside ES relocate to D.A. Morrison MS and convert from a Junior Kindergarten to Grade 5 single track school to a Junior Kindergarten to Grade 8 dual track school (Regular and French Immersion), and assume a portion of the Earl Beatty Jr & Sr PS French Immersion catchment area;
- That a formal name change process be approved to consider a name change for the consolidated Parkside ES / D.A. Morrison MS; and
- That Gledhill Jr PS remain a Junior Kindergarten to Grade 6 school feeding in its entirety to D.A. Morrison MS for both Regular and French Immersion at Grade 7.

Following the completion of the review, while staff was considering its response to the PARC's recommendations, the Ministry of Education imposed a capital freeze at the Board that lasted from October 2012 to July 2013. This meant that the Toronto District School Board was not able to proceed with any major capital projects.

During the capital freeze, the Ministry shared its general expectation that the Board consider the following no-cost or low-cost planning alternatives prior to concluding that capital expenditures are necessary:

- · Boundary changes
- Grade re-configurations
- Re-directions of residential development
- Use of excess space in other schools
- Relocation of programs to other schools with space
- Use of portables as a short-term solution
- · Timetable changes for secondary schools

As a result, staff reconsidered all accommodation projects that were on hold during the capital freeze and developed recommendations that were consistent with the Ministry's expectations. Proposed capital projects were eliminated or reduced in scope by using available space in other schools in the system.

While the Board has since approved a balanced capital budget which included both planned expenditures and revenue sources for major capital projects, Ministry approval is still required for all capital expenditures. The Ministry reviews all proposed capital

projects to make sure that they align with their general expectations.

Staff has reviewed the PARC's recommendations within the context of this new fiscal reality. Staff has developed recommendations that eliminate the need for capital expenditures and make good use of existing space. Staff has consulted with Ministry staff who has confirmed that the recommendations meet their general expectations.

Staff is recommending the following:

- That Secord ES remain a Junior Kindergarten to Grade 5 school;
- That Parkside ES remain a Junior Kindergarten to Grade 5 school;
- That D.A. Morrison MS remain a Grade 6 to 8 school and become a dual track school (Regular and French Immersion) effective September 2016;
- That Earl Beatty Jr & Sr PS French Immersion students feed into D.A. Morrison MS at Grade 6 effective September 2018; and
- That Gledhill Jr PS convert from a Junior Kindergarten to Grade 6 school to a Junior Kindergarten to Grade 5 school feeding into D.A. Morrison MS for both the Regular program (starting with Grade 6 in September 2018) and the French Immersion program (starting with Grade 7 in September 2016 and Grade 6 in 2018).
- That the Community Access Program (a Caring and Safe Schools Program for students with attendance issues) relocate from Earl Beatty Jr & Sr PS to D.A. Morrison MS.

Appendix B contains a summary and comparison of the accommodation plans recommended by the PARC and staff.

Appendix C sets out staff's response to each of the PARC's recommendations.

Appendix D lists all the changes that staff is recommending with the rationale for each change.

Planning and enrolment data for the schools in the review can be found in Appendix E.

At the final community meeting held on 27 April 2015 at which staff shared their recommendations, the parents expressed the following concerns:

- Parents were not supportive of changing the grades of Gledhill Jr PS from Junior Kindergarten to Grade 6 to Junior Kindergarten to Grade 5. They believe Grade 6 is too young an age for a transition. They like the Grade 7 transition point which allows them to apply to other programs in the area that start at Grade 7.
- Parents were not supportive of the change in feeder path for Gledhill Jr PS French Immersion students away from Glen Ames Sr PS and into D.A. Morrison MS. They like attending Glen Ames Sr PS which has an established French Immersion program.
- Parents were concerned that the portapak at Secord ES was not being replaced with a permanent addition. They feel that the portapak has reached the end of its lifespan.
- Parents were concerned that it would take several years for the enrolment to grow at D.A. Morrison MS the proposed phasing of the grade changes is not happening fast enough to provide a strong program at D.A. Morrison MS. They would like enrolment growth for next school year.

Despite the above concerns, staff believes that the recommended student accommodation plan in this report provides the best balance of enrolment across the schools, delivers strong program options, maintains a TDSB presence in neighbourhoods, minimizes disruptions for students and families, achieves an efficient use of existing space, and incorporates the perspective of the Ministry of Education.

RESOURCES

No additional resources will be required to implement staff's recommendations.

IMPLEMENTATION AND REVIEW

If approved, staff's recommendations will be implemented as per the timelines indicated in this report.



Staff does not support the recommendation to relocate Parkside ES due to the capital costs associated with retrofitting DA Morrison MS to accommodate primary grades. Staff supports the part of this recommendation regarding the introduction of French Immersion at D.A. Morrison MS. Staff recommends that French Immersion span Grades 6 to 8.

APPENDIX F

RECOMMENDATIONS

The D.A. Morrison Pupil Accommodation Review Committee recommends:

- 1. That Secord Elementary School convert from a JK to Grade 5 to a JK to Grade 8 school;
- 2. That Parkside Elementary School relocate to D.A. Morrison Middle School and convert from a JK to Grade 5 single track to a JK to Grade 8 dual track (Regular and French Immersion) school;
- 3. That a formal name change process be approved to consider a name change for the consolidated Parkside Elementary School/D.A. Morrison Middle School; and
- 4. That Gledhill Junior Public School remain a JK to Grade 6 school feeding in its entirety to D.A. Morrison Middle School for both Regular and French Immersion at Grade 7.

RATIONALE

Background

Presently, D.A. Morrison Middle School's feeder pool consists of Crescent Town Elementary School, Parkside Elementary School and Secord Elementary School at Grade 6 and Gledhill Junior Public School at Grade 7. However, a Program Area Review Team (PART) process conducted in the fall of 2011 will result in the removal of Crescent Town Elementary School as a feeder to D.A. Morrison Middle School for Grade 6.

During the Crescent Town PART process, the Secord Elementary School community expressed serious interest in converting from a JK to Grade 5 to a JK to Grade 8 school, however, the final recommendation to change the grade configurations and the Board-approved boundary change did not result in changes to Secord Elementary School's grade range. The implications of additional changes to D.A. Morrison's feeder pool would require a pupil accommodation review to consider grade-range and program options for all of the remaining feeder schools (Gledhill Jr PS, Parkside ES and Secord ES).

On March 6, 2012, the Board recommended that a Pupil Accommodation Review Committee (PARC) be established for D.A. Morrison Middle School, Gledhill Junior Public School, Parkside Elementary School and Secord Elementary School.

The pupil accommodation review provides an opportunity to:

- Consider program and grade range changes for the long-term accommodation of students for schools named in the process.
- Address concerns around a substantial port-a-pak (14 rooms) at Secord ES that is in need of replacement.

Ensure capital to implement Full-Day Kindergarten is directed appropriately to support the long-term program vision for the area.

At the end of the second working meeting the Committee was asked if any of the through options discussed in detail represented an accommodation solution that they would recommend as the Committee's emerging preferred option for the Public Open Houses. Consensus was achieved by the Committee to recommend Option 4.

Summary of Findings

Four public Open Houses were conducted to provide information about the work of the PARC to date and to receive feedback from each school community directly. Staff members from the Planning, French, Special Education, and Employee Services departments had stations to present information and respond to the public's questions. Each member of the public who attended the Open House was provided with a survey form and encouraged to fill it out and leave their feedback, questions or concerns.

A third PARC working meeting was held after the four public Open Houses had been completed in order to review the public feedback that was received and to determine if it changed the Committee's recommended option in any way. Much of the feedback related to issues, concerns and benefits that had been identified and discussed by the Committee at earlier working meetings.

After the feedback from the public had been presented and reviewed, the Committee was asked if any of the public feedback received required further discussion or changed the Committee's support for Option 4. The Committee agreed that none of the feedback changed the Committee's thinking and that there was still consensus for recommending Option 4 as the preferred accommodation option to the Board of Trustees.
